Vendor Booth Requirements

Please initial in front of each item to acknowledge understanding and compliance.

- ___ Vendor application will be reviewed in order of submission. Vendor understands they will receive a confirmation by Tuesday, June 2 with day of event details.
- ___ Vendor understands submitting an application does not guarantee a space.
- ___ Each vendor is to review the requirements with all representatives working the booth.
- ___ Vendor must bring their own 10'X10' canopy, tables and chairs. Mandatory to bring a minimum of 25lbs. of weight per leg to weigh down canopy, no staking allowed (weights available on Amazon, Home Depot, or Lowes).
- ___ Tables and chairs (one 8' table and up to three chairs) can be provided for an additional \$15.00.
- ___ Commercial and Craft vendors are required to provide a Montclair business license if selling items at the event. Contact Catherine Mercado at City Hall at (909) 625-9423 for more information regarding the one day license (fee waived for Country Fair Jamboree).
- ___ No food sales and no electricity.
- ___ Set-up time from 8:30 a.m.-10:00 a.m. Vendors must stay until 6 p.m.
- ___ Vendors who arrive late for set up will not be allowed access and will forfeit their fee.
- ___ No-shows will forfeit their fee.
- ___ \$100 deposit will be refunded to those non-profit vendors who show up on time and don't leave prior to 6:00 p.m.
- ___ All vendors will be outdoors and must bring their booth supplies in from adjacent parking lot. No driving into park. Vehicles will unload from the parking lot.
- ___ After set-up, vehicles must be moved to a designated offsite parking lot.
- ___ No political campaigning/ slogans at booth and or banners. All banners must be approved by Community Services Supervisor.
- ___ No consumable giveaways including no sales of food and beverages.

Application deadline is Thursday, May 14, 2026.
